

The Parent Loan for Undergraduate Students (PLUS) is a federal educational loan. It is the only Federal aid type that can be awarded without a completed Free Application for Federal Student Aid (FAFSA). **If you are completing this form, we will assume that you do not wish to apply for any other federal or state financial aid.** If this is incorrect, please contact our office for the appropriate form.

The parent is the borrower of this loan. Students are required to meet Satisfactory Academic Progress requirements. The amount that can be borrowed is based on the standard cost of attendance and any other aid awarded. Eligibility: Parents eligible to borrow the PLUS Loan are a biological parent (including a non-custodial parent), an adoptive parent, or a stepparent.

Repayment: The first payment of the PLUS Loan is due no later than 60 days after the loan is fully disbursed. The standard repayment period is ten years. The minimum monthly payment is \$50 or the interest due on the loan, whichever is greater. The interest rate is fixed at 7.9%.
