The Parent Loan for Undergraduate Students (PLUS) is a federal educational loan. The parent is the borrower of this loan. It is part of the student's financial aid package and students are required to meet Satisfactory Academic Progress requirements. The amount that can be borrowed is based on the cost of attendance less any other financial aid awarded. Eligibility: PLUS borrowers must be either: the biological parent, adoptive parent, or stepparent of the student. Stepparent eligibility is limited to those whose income and assets are taken into account when calculating the student's Expected Family Contribution (EFC). Non-custodial parents may also borrow PLUS loan (a different PLUS-only application is required). Borrowers must sign a master promissory note (MPN). This can be done online at: www.dlenote.ed.gov.
